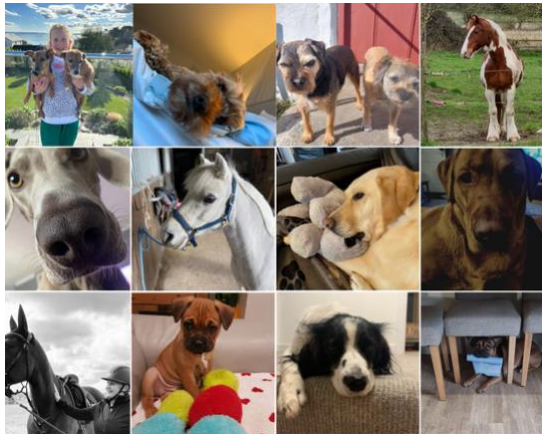


## Sarah Davies
