

# FREQUENTLY ASKED QUESTIONS

## What qualifications do I need to become an expert witness?

You should be a Registered Nurse with the Nursing and Midwifery Council (NMC), Occupational Therapist or Physiotherapist with the Health and Care Professions Council (HCPC) and have ten years or more of clinical experience in your specialist area.

## What specific areas of expertise might an expert witness cover?

Expert witnesses often specialise in the following areas: breach of duty and causation, care needs assessment, equipment and adaptation recommendations, rehabilitation planning, vocational/functional capacity evaluation, and loss of service assessment.

## Do I have to leave my current NHS or Private Practice role?

No. An expert witness role is self-employed and can be managed around employed or other self-employed work.

## What are the main responsibilities of an expert witness?

The primary responsibilities include conducting thorough assessments, writing detailed reports, providing objective, evidence-based opinions, and potentially giving oral evidence in Court. You must provide opinions within your area of expertise and always remain impartial.

## What key skills are required?

Key skills include excellent written and verbal communication, logical reasoning and the ability to defend recommendations and remain calm under cross-examination. You must also be able to express complex ideas clearly and maintain objectivity.

## How long is a typical case?

The duration of a case can vary significantly. Some are resolved in months, while others, particularly paediatric cases, can last several years. Expert witnesses must be prepared to commit to a case for its entirety.

## How does expert witness work differ from standard clinical practice?

Expert witness work often allows for more creative thinking beyond statutory service limitations. It requires high levels of accuracy, attention to detail, and the ability to analyse medical evidence. The work is often more varied and challenging than standard clinical roles.

## Will I have to attend Court?

Most cases settle before they reach Court, thus eliminating the need to attend. We provide full training and dedicated support should you have to attend Court.
