We held in-house training sessions for all our experts, including an online update on 'Recent Case Law involving Expert Witnesses' provided by Daniel Green from Novum Law.

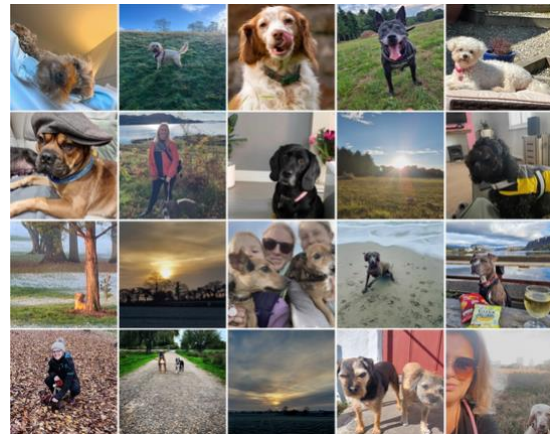
